Dr. R. Parthasarathy Award

Dr. R Parthasarathy award has been instituted in the memory of Dr R. Parthasarathy, Former Professor & Head, Department of Psychiatric Social Work; Consultant, Community Psychiatry Unit; Consultant, Family Psychiatry Centre, NIMHANS, Bangalore.

The award rules are as follows:

The Award would be given to the best paper among those submitted for consideration of this award, in the field of **Student and Community Mental Health**.

In order to compete for this award:

- 1. The first author (who will be the presenting and corresponding author) must submit the full manuscript of the paper and he/she shall be a life member of Association of Psychiatric Social Work Professionals (APSWP).
- 2. The first author should present the paper in the National Conference of APSWP.
- Submission must be original qualitative or quantitative research studies. Metanalysis, systematic reviews and case studies/case series will be accepted. Submitted paper should be made as per "instructions for manuscript preparation"
- 4. A panel of judges (minimum three members from the field of Psychiatric Social Work) constituted by the organising committee of the conference shall examine and take decisions on the paper.
- 5. Paper submitted for consideration of Award must not have been presented, published, accepted for publication or submitted for consideration elsewhere.
- 6. Only one submission is allowed from a member as first author for this award.
- 7. Soft copies of the full written version of the paper must be submitted to the Organising Secretary (or any other person notified on the website of APSWP/ Organising Institute or in Conference Brochure) on or before the stipulated date decided by the Executive Council (and as displayed on the website of the APSWP / conference website).
- 8. The manuscript submitted will be judged on the basis of written manuscript and paper presentation; the weightage will be 75: 25 respectively.
- 9. Members of the judging panel shall not be contestant for this Award nor should be a co-author in the award paper submitted. Judging members are allowed to contest for any Awards in other categories.
- 10. A cash award of Rs. 5000/- and a certificate will be given as prize. All authors will be issued certificates.
- 11. The award winning paper shall be published in reputed journals by the authors with due acknowledgement of the award status.
- 12. The announcement of all the Award will be made at the annual general body meeting.
- 13. The decision of the Judges / Executive Council shall be final and binding on all the matters related to AWARDS.
